SUGGESTION(S) FOR FUTURE IFBLS ACTIVITIES AND HOW YOU PLAN TO DEVELOP EACH:

I would like to support IFBLS activities that strengthen global engagement and raise the visibility of the profession. The Icelandic Association of Biomedical Scientists (IABS) became a member of IFBLS in 1970 and has maintained active involvement in IFBLS activities over the decades, including Icelandic representation on the IFBLS Board of Directors and in the role of IFBLS President. The history of IABS's commitment to the international professional community has shaped my understanding of the value of sustained international collaboration and the importance of creating opportunities for both established and newer member associations to contribute meaningfully, and it strengthens my wish to contribute constructively to IFBLS's future work.

Building on this history, I see value in initiatives to increase membership by reaching underrepresented regions and supporting national societies in joining IFBLS. I stand before the global Biomedical Laboratory Science community with a deep sense of responsibility, humility, and purpose. As a Professor Coordinator at ESTeSC - Coimbra Health School, I have shaped the next generation of biomedical laboratory scientists, instilling in them the values of scientific rigour, patient safety, and professional excellence. As a researcher affiliated with the Coimbra Institute for Clinical and Biomedical Research (iCBR) and the Health & Technology Research Center (H&TRC), I have contributed to expanding the frontiers of knowledge in oncobiology, transfusion medicine, and health literacy – areas that sit at the very heart of modern laboratory diagnostics.

SUGGESTION(S) FOR FUTURE IFBLS ACTIVITIES AND HOW YOU PLAN TO DEVELOP EACH:

If elected, I would be interested in actively contributing to the strategic development and work of the IFBLS, by aligning with the 2024-28 strategy in the following ways: -

Education and Professional Development:

I would support expansion of accessible professional development opportunities that strengthen competence, encourage knowledge exchange and ensure equitable access. I would wish to build on the work already done using the Britta Karlsson Advancement Program and the Britta Karlsson Educational webinar series to support international training and to benefit member associations. Many member countries face similar issues in staff shortages, for example, and to be able to share and promote best practice by developing forums where members can compare approaches to workforce development, regulation and innovation is key.

Promote the profession:

Long term sustainability depends on attracting more early career biomedical scientists into professional leadership roles. I would use social media platforms, such as LinkedIn to encourage participation in working groups and policy discussions, with the aim of developing an early career advisory network linked to IFBLS. In addition, I would promote international awareness campaigns to highlight the central role of biomedical laboratory scientists.

My motivation for seeking election to the Board of Directors is to contribute effectively to future strategies by sharing the knowledge, experience and professional insight I have gained from my roles serving the IBMS as well as my role as a biomedical scientist and senior manager of a blood sciences service.

I am highly motivated, organized and reliable. In my 10 years as IBMS Council member I have never missed a council meeting. I have served as chair of the Education & Professional Standards committee, remuneration committee, audit committee, strategic research group and was on the specialist advisory panel for clinical chemistry for 8 years.
